### Section 3. Hazard Identification

**Emergency overview**: Harmful! Harmful if swallowed. Irritating to eyes. Avoid contact with skin and eyes. Keep locked up and out of the reach of children.

Routes of entry: Ingestion, inhalation, contact with skin and eyes.

**Health hazards**: Inhalation: This product may be harmful if inhaled. Product is unlikely to cause any discomfort or irritation unless inhaled in large quantities. Skin Contact: This product causes skin numbness but further symptoms are not available. In addition, product is a skin irritant. Symptoms may include itchiness and reddening of contacted skin. Other symptoms may also become evident, but all should disappear once exposure has ceased. Eye Contact: This product is an eye irritant. Symptoms may include stinging and reddening of eyes and watering which may become copious. Other symptoms may also become evident. If exposure is brief, symptoms should disappear once exposure has ceased. However, lengthy exposure or delayed treatment may cause permanent damage. Ingestion: Harmful if ingested. **Environmental hazards**: Toxic to fish and aquatic arthropods. Toxic to bees.

## Section 4. First Aid Measures

## **Section 5. Fire Fighting Measures**

Flash point: Not highly flammable.

**Hazardous combustion products**: Carbon monoxide, carbon dioxide, chlorine, fluorine, hydrogen chloride and hydrogen fluoride.

**Extinguishing media**: Water fog (or if unavailable fine water spray), foam, dry agent (carbon dioxide, dry chemical powder).

Media to be avoided: None known.

**Fire-fighting instructions:** If a significant quantity of this product is involved in a fire, call the fire brigade. There is little danger of a violent reaction or explosion if significant quantities of this product are involved in a fire.

**Protective equipment for firefighters**: On burning will emit toxic fumes. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

## Section 6. Accidental Release Measures

**Personal precautions**: Isolate and post spill area. Keep out unprotected persons and animals. Wear prescribed protective clothing and equipment. Avoid breathing vapors. Work up wind or increase ventilation.

**Environmental precautions**: DO NOT allow spilled product or wash solution to enter sewers, drains, dams, creeks or any other waterways.

**Method for cleaning up**: Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. If spill is too large or if absorbent material is not available, try to create a dike to stop material spreading or going into drains or waterways. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency service

### Section 7. Handling & Storage

**Handling:** Read the label before use. Avoid skin and eye contact and breathing in vapour. Keep out of reach of children





**Storage:** Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Store in a locked room or place away from children, animals, food, feedstuffs, seed and fertilizers. where there is a potential for exposure to the material. Do not dilute concentrate in food or drink container.

### Section 8. Exposure Control, Personal Protection

**Exposure limits**: No exposure limits have been established for this material.

**Engineering controls**: Use in a well-ventilated area. Use with local exhaust ventilation or while wearing organic vapor / particulate respirator. Keep containers closed when not in use. **Personal protective equipment (PPE):** Ventilation: No special ventilation requirements are normally necessary for this product. However, make sure that the work environment remains clean and that vapours and mists are minimised. Eye Protection: Protective glasses or goggles should be worn when this product is being used. Failure to protect your eyes may cause them harm. Emergency eye wash facilities are also recommended in an area close to where this product is being used.

**Skin Protection:** Prevent skin contact by wearing impervious gloves, clothes and, preferably, apron. Make sure that all skin areas are covered. See below for suitable material types.

**Protective Material Types:** We suggest that protective clothing be made from the following materials: PVC, nitrile, neoprene. Respirator: If inhalation risk exists, wear a properly fitted half-face or full-face air purifying respirator which is approved for pesticides. Eyebaths or eyewash stations and safety deluge showers should be provided near to where this product is being used.

**User safety recommendations**: Avoid contact with eyes and skin. Avoid inhaling spray mist. When preparing spray, wear cotton overalls buttoned to the neck and wrist and washable hat, elbow-length PVC gloves and goggles. When using the prepared spray with hand held application equipment in bananas and grapes, wear cotton overalls buttoned to the neck and wrist and elbow length PVC gloves. Wash hands after use. After each day's use, wash gloves, goggles and contaminated clothing.
