**3. HAZARDS IDENTIFICATION**

- Health Hazards** : Synthetic pyrethroids can produce paresthesias. Typically symptoms begin several hours after cutaneous exposure, peaks within about 12 hours and resolves within about 12 hours. Extraordinary absorbed doses may rarely cause tremor, hyper-excitability, uncoordinated movements, salivation, nausea and vomiting & diarrhea.
- Emergency** : Warning! Keep out of reach of children. Toxic if swallowed and by inhalation.
- Skin and Eyes** : Avoid contact with skin and eyes.
- Entry route** : Ingestion, Inhalation, Contact with eye or skin.
- Symptoms of poisoning** : Paraesthesia, particularly involving the face, dizziness, headache, nausea, anorexia and fatigue. Less common findings included chest tightness, palpitations, blurred vision, increased sweating and low-grade fever.

**4. FIRST AID MEASURES**

- Ingestion** : DO NOT induce vomiting. Rinse any residual product from mouth and lips. Give water to drink and seek medical advice.
- Eye** : Immediately flush eyes with running water until product is removed. Seek medical advice if irritation persists.
- Skin** : Remove contaminated clothing. Wash thoroughly under running water using a mild soap to remove all products. Seek medical advice if irritation, reddening and/or other damage occurs.

- Inhalation** : Remove victim from exposure. Keep at rest until fully recovered. Seek medical advice if effects persist.
- Advice to Physician** : No specific Antidote. Treat symptomatically.

### 5. FIRE FIGHTING MEASURES

- Specific Hazard** : There is no risk of an explosion from this product under normal circumstances if involved in a fire.
- Extinguishing Media** : Extinguish fire using media suited to burning material. If containers are ruptured contain all runoff. CO<sub>2</sub>, Foam or dry chemical are preferred. Soft stream water fog or fine water sprays if no alternatives. Contain all runoff.
- Hazard From Combustion products** : If involved in a fire, it will emit toxic and noxious fumes of oxides of carbon, nitrogen or sulfur. Firefighters to wear self-contained breathing apparatus and suitable protective clothing if risk to of exposure to vapour or smoke.

### 6. ACCIDENTAL RELEASE MEASURES

- In Case of Emergency** : Isolate and post spill area. Wear cotton overalls buttoned to the neck and wrist, washable hat, elbow-length PVC gloves and eye/face protection to prevent skin and eyes being affected. Evacuate unprotected and unnecessary personnel from area of spill. If material is leaking from a container, stop the leak only if this can be done safely. Prevent spillage entering drains or watercourses. Contain spill and absorb spilled material with absorbent material such as sand, clay or cat litter and dispose of waste as per regulations.
- Clean up Procedures** : To decontaminate spill area, tools and equipment, wash with detergent and water and add the solution to the drums of wastes already collected and label

contents. Do NOT allow spilled product or wash solution to enter sewers, drains, dams, creeks or any other waterways.
